Satish Reddy is the Chairman of Dr. Reddy's Laboratories. He joined the company in 1993 and since then has held positions of increasing responsibility. Satish led the organization's transition from a uni-focused manufacturer of APIs (active pharmaceutical ingredients) to a company that moved up the value-chain with a diverse product portfolio of Finished Dosage Formulations. He oversaw the expansion and establishing of a strong footprint for Dr. Reddy's finished dosage products in Russia, China and other emerging markets.

As an active member of major industry associations and governmental panels, Satish played a key role in shaping policies concerning the pharmaceutical sector that include India's patent law, drug pricing and important amendments to the Drugs &Cosmetics Act. He is a Member on the IGBA CEO Advisory Committee. He was the President of the Indian Pharmaceutical Alliance, a premier industry association of leading research based Indian companies from 2019-2021 & 2013-2015. He was the Chairman of the Life Sciences Skill Development Council under He was the Chairman of the Board of Governors of NIPER Hyderabad. He was a member of the Drugs Technical Advisory Board of India, the Chairman of the Andhra Pradesh Chapter of the Confederation of Indian Industries (CII) and head of its National Committee on Pharmaceuticals. In May 2015, the Ministry of Labour and Employment, Government of India, nominated Satish as Chairman of the Board of Governors of Governors of Governors of the National Safety Council.

Keeping true to the legacy of the founder of the company, Dr. Anji Reddy, Satish drives the organization's Corporate Social Responsibility initiatives. The Dr. Reddy's Foundation, of which he is Chairman, works to help the less privileged create sustainable livelihoods through appropriate vocational education. He is a Trustee of the Naandi Foundation, which works in the areas of child rights and education, safe drinking water, agriculture export marketing support and other much needed empowerment initiatives that India need. Satish is also one of the Directors of Dr. Reddy's Institute of Life Sciences, the not-for-profit institute engaged in pioneering and innovative research in unifying areas of chemistry, biology and chemical biology.

Satish was identified as a "Young Global Leader for 2007" by the World Economic Forum, and was presented with the "IBLA - India Corporate Citizen of the Year" award by CNBC in 2005 for his contributions to Corporate Social Responsibility. He holds a degree in Chemical Engineering from Osmania University, India, and an M.S. in Medicinal Chemistry from Purdue University, USA, where he received the 2009 Distinguished Alumnus Award from the School of Pharmacy and Pharmaceutical Sciences.

Daren Tang, a national of Singapore, began his six-year mandate as Director General of the World Intellectual Property Organization (WIPO) on October 1, 2020. Prior to his appointment as WIPO Director General, he served as Chief Executive of the Intellectual Property Office of Singapore (IPOS), driving the strategic transformation of IPOS in support of Singapore's innovation-based economy.

Between 1997 and 2012, before joining IPOS, Daren Tang held different legal positions within the Attorney-General's Chambers and the Ministry of Trade and Industry of Singapore. In 2016, he received the Public Administration Medal from the Prime Minister's Office Singapore for outstanding efficiency and competence in the service of his country.

Daren Tang is a graduate of the National University of Singapore (Bachelor of Law, Honors) and the Georgetown University Law Center (Master of Laws, Distinction). He also attended the Advanced Management Program at Harvard Business School. He is fluent in English and Chinese.

Ms. Sumita Dawra is an Indian Administrative Service Officer of the 1991 Batch, with experience of more than three decades in public administration in India and abroad. Her postings include working with Ministry of Finance, Government of India, for six and a half years, which included tenure of about three and a half years in China, as the head of the Economic Wing in the Indian Embassy (2008-2014). She has also done a stint with the United Nations as a Governance Specialist (2017-2019).

She was posted as District Collector of Karimnagar district in Andhra Pradesh (now Telangana State) (2001-2004), where she had the rare opportunity to work as the highest convergence point for development work for a population of 3.6 million people. Successful outcomes in education and child labour eradication resulted in the International Labour Organization (ILO) publishing a manual written by her on methods and principles used for child labour eradication through convergence strategies.

Ms. Dawra is currently Special Secretary (Logistics), DPIIT and her responsibilities include Logistics, PM Gatishakti, ongoing work in Industrial Corridors, etc. She has been with DPIIT, M/o Commerce & Industry since August 2019. Her work in DPIIT includes: development and soft launch of the country's first National Single Window System (NSWS), launch of a GIS-enabled India Industrial Land Bank, work related to One District One Product (ODOP), monitoring of all Production Linked Incentive (PLI) Schemes across Ministries, oxygen management during COVID at Central level, to name a few.

Her public policy experiences led her to author several articles and two best-selling books on public policy, namely 'Poor but Spirited in Karimnagar: Field notes of a Civil Servant,' (Harper Collins, 2012) and a well-respected book on the Chinese economy and public policy, titled: 'China: Behind the Miracle,' (Bloomsbury, 2015). She holds an MBA and MPhil (Economics) from Punjab University, Chandigarh (India) and an MBA (Public Policy) from The School of Public Policy, University of Birmingham, UK.

R Saha (Mr) Senior Advisor

Mr R Saha is a B Tech from IIT Kanpur in Aeronautical Engineering. He got his master's degree from Cranfield University in England. He served the Government of India for 35 years in different capacities and handling different responsibilities including research and development and retired as Scientist G and Adviser from the Department of Science and Technology, Government of India. He has wide experience in technology evaluation and assessment, intellectual property rights management, regulatory processes and R&D policies and project implementation. He has been a pioneer in leading the national efforts in policy making and capacity building in IPR. He planned and conducted two training programmes on IPR for developing countries drawing a participation of about 30 countries. He was invited as an international resource person to speak on IPR in Bangladesh, Indonesia, Namibia, Sri Lanka, Egypt, Oman, Malaysia, China, Philippines, Mauritius, Mexico, and Uganda. He conducted more than 400 IPR workshops in India and other countries. 20 Patent Information Centers at state levels and 60 university IPR cells were set up in India under his leadership. He has been helping universities in developing their IPR policies. About 1000 patent applications were filed under his guidance on behalf of universities and R&D institutions. He represented India in discussions at WIPO and, was involved in negotiating international agreements on IPR in the context of scientific research and development.

He was appointed a consultant by the World Intellectual Property Organization (WIPO) to prepare a National Study on IPR and MSME in India as a part of WIPO's Development Agenda. The study was completed in 2012.

He has been the Senior Adviser to CII since 2011, advising them on IPR policies and other substantial issues being faced by the Indian industry like preparing policy papers, conducting round table meetings with industries, international organizations etc. He is also the Chairman of the committee set up by the Department of Electronics and Information Technology, Government of India for providing IPR support to start ups and conducting awareness programmes. He was the MHRD Chair Professor in IPR at the Tezpur University, a Central university. Presently, he advises many institutions like IIT Delhi, IIT Kharagpur, C-DAC, NRDC, Indian Council of Medical Research and many government departments on IPR matter.
